## Range rules and additional information:

- Shoot setup and site-in period: April 29, 2010
- Dates open to public: April 30, May 1, May 2
- Shooters meeting: Thursday, April 29<sup>th</sup> - 1:00pm (may change); Friday, Saturday, and Sunday mornings at 7:30am.
- All shooters must have a signed release of liability contract on file and wear ID (provided by RMMGS).
- Open chamber markers required and provided.
- Shooters with NFA firearms must show paper work.
- All persons on the firing line must wear eye and ear protection.
- We run a cold firing line!
- No rain checks - we shoot rain or shine.
- Shooters: no benches, shelter or seating available - bring your own.
- Targets from 100 yards to one mile
- Some food and drink will be available on-site.
- **No alcoholic beverages allowed on the property.**

## Directions to shoot site:

**From Denver:** Take I-70 east to Limon, CO. **EXIT 363**. Then go southeast to Kit Carson on Hwy. 287/40. Then take 40 east to First View just west of Cheyenne Wells. At shoot signs, go north 4.5 miles on CR 34 to the intersection with CR V. Approximately 185 miles.

**From East of Colorado:** Take I-70 to Burlington, CO. **EXIT 437**. Then go south on Hwy. 385 to Cheyenne Wells. Then go west on Hwy 40 about 12 miles to First View. At shoot signs go north 4.5 miles on CR 34 to the intersection with CR V.

**All distances are approximate!**
